**Subject: - Engagement of Guest Teachers in the ASM for the Academic Year 2022-23-reg..**

महोदय/ Sir,

With reference to your E-mail letter no. HASCJ-CSU/23(1)/22-23/33 dated 18.05.2022 received in this office on the subject cited above, I am to inform you that the Competent Authority of Central Sanskrit University has approved the engagement of Guest Teachers in ASM as mentioned below for the Academic Session-2022-23:-

Guest Teacher (s)	Sahitya	01	A maximum of Rs 40,000/- per month (For minimum of 40 hours per month) in the Academic Year-2022-23 or till the permanent appointment is made, whichever is earlier, as per rule.

	Computer Instructor	01	A maximum of Rs 40,000/- per month (For minimum of 40 hours per month) in the Academic Year-2022-23, as per rule.
	Guest teacher in Environmental Studies	01	Rs. 1500/- per lecture to a maximum of 50 lectures in Academic session 2022-23, as per rule.

The guidelines for the engagement of Guest Teachers are as under:-

1. The Guest teacher who possesses the required qualification may be paid Rs. 40,000/- Maximum (For minimum of 40 hours per month).
2. The above engagements are to be made purely on temporary basis for a fixed period for the academic year 2022-23.
3. The Guest Teachers will not be entitled to any other benefits such as confirmation, TA, HRA etc. which is admissible to the regular employees of the Mahavidyalaya. He/she will have no claim for regularization/seniority on the basis of engagement. The institution reserves the right to terminate this engagement anytime before the stipulated time, without assigning any reason.

4. The engagement of Guest Teacher is to be made as per the Revised Scheme of ASM/ASS by observing the UGC Regulation/Central Government rules.
5. The Guest Teachers may be engaged for the academic session 2022-23 as per the approved strength mentioned in this letter. The period of engagement of the Guest Teachers will be from the date of starting of Academic Session as per affiliating University's academic calendar or from the date of joining of the Guest Teacher, whichever is later. The term of the Guest Teacher will be upto the last working day of academic session 2022-23 or till the permanent appointment is made, whichever is earlier.
6. The qualifications for the Guest teachers should be same as prescribed for Assistant Professor of Universities/Colleges by the UGC's Regulations 2018/Central Government rules.
7. Selection procedure for engagement of Guest teachers should complete within one month from the date of issue of this letter and the same is to be communicated to this office with all details.
8. Selection Committee for selection of Guest Faculty shall be constituted as per UGC norms. Further, a separate letter to be sent to this office for subject expert and Vice Chancellor's nominee after completion of application process.
9. The Guest teachers will be entitled for 08 days of casual leave on pro-rata basis and 02 RH for the one academic session of engagement.
10. The Guest teachers should have to perform the duties as assigned by the Principal of Mahavidyalaya.
